Early Years Pupil Premium (EYPP) is additional funding that is available to Early Years Providers to support children's development, learning and care.

If you receive one or more of the benefits listed below you could attract this funding:

- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- Support from NASS (National Asylum Support Service) under part 6 of the Immigration and Asylum Act 1999
- · The guaranteed element of State Pension Credit
- Child Tax Credit (provided the family are not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190)
- Working Tax Credit run-on (the payment someone may receive for a further 4 weeks after they stop qualifying for Working Tax Credit)
- Universal Credit –provided you have an annual net earned income of no more than £7,400 as assessed by earnings from up to three of your most recent assessment periods.

Early Years Pupil Premium is paid directly to early years providers based on the number of universal funded hours that a child attends to improve the quality of the Early Years Education provided for your child.
